The proposer will also be requested to provide responses to Selection Committee questions. The oral interviews will be scored as follows:</i></p> <p><i>Project Approach 10 points</i> <i>Methodology 10 points</i> <i>Cost aspects 20 points</i> <i>Responses to Selection Committee questions 10 points</i></p> <p>The panel will reach a consensus and make recommendations to the Agency Partnersø Executive Directors following evaluation of 1) written proposals and 2) performance at the oral interview. The Agency Partners reserve the right to select a consultant based solely on written proposals and to not convene oral interviews.</p> <p>The Agency Partnersø Executive Directors will review the recommendation and make a recommendation to the Agency Partnersø respective Boards of Directors. If the Boards of Directors select a different consultant than the one recommended, the Agency Partners, in consultation with their Executive Directors, will prepare a memo explaining the selection.</p>
