#### 5. ORAL COMMUNICATIONS FROM THE BOARD ON ITEMS NOT ON THE AGENDA

President Funk welcomed new AMBAG Board members from the cities of Del Rey Oaks, Greenfield, Hollister, Marina, Pacific Grove, Santa Cruz, Scotts Valley, Soledad, and the counties of Monterey and San Benito.

#### 6. STAFF INTRODUCTION

Maura Twomey, Executive Director introduced Elisabeth Hurtado-Espinosa AMBAG's Principal Planner.

#### 7. PRESENTATIONS

#### A. AMBAG Energy Watch Program

Elisabeth Bertrand, Director of Special Projects reported that the AMBAG Energy Watch Program has been in service to the AMBAG region since 2006. The AMBAG Energy Watch Program has achieved 1) 103.5 million annual kWh of energy savings from 2006 – 2019; 2) 6 million in annual kWh of annual energy savings projected for 2019; 3) \$75 million saved from being spent on energy to be used other ways in the community; and 4) provided technical assistance to acquire \$40+ million in grants or loans for the jurisdictions, school districts and special districts. Mrs. Bertrand added that in 2019 the AMBAG Energy Watch 1) worked with local governments and special districts; 2) worked with small businesses, non-profits, the hospitality sector, and the agribusiness sector; 3) worked with school districts; 4) provided education and training; and 5) provided technical support for all jurisdictions including help with greenhouse gas inventories, energy action strategies and climate planning.

Amaury Berteaud, Special Projects Associate gave an update on the AMBAG region school districts and the California Clean Energy Jobs Act: Proposition 39 Projects. Mr. Berteaud reported that the California Energy Commission (CEC) has made available \$36.7 million in Prop 39 funding for the AMBAG region's school districts. Staff worked with 80 percent of the school districts and \$44.4 million of the available Prop 39 funding to 1) conduct energy benchmarking and energy audits; 2) define energy efficiency projects scopes; 3) write Energy Expenditure Plans to request funding allocations from the CEC; 4) write technical specification documents for RFP processes; 5) support project implementation and provide rebates; and 5) prepare the annual progress reports to the CEC. The AMBAG Energy Watch Prop 39 outcomes are 1) staff wrote Energy Expenditure Plans for 162 individual school sites; 2) over 200 schools and district offices were retrofitted with LED lighting; 3) more than \$2 million in annual energy savings were generated (10 million kWh) from LED lighting projects alone; 4) major HVAC, solar and smart thermostat projects; and 5) 80% of Prop 39 projects

were completed. Mr. Berteaud reported that the AMBAG Energy Watch Program has worked with 87 schools in Monterey County; 21 schools in San Benito County; and 54 schools in Santa Cruz County. Brief discussion followed.

#### A. Executive/Finance Committee

President Funk reported that there was no quorum for the Executive/Finance Committee. The Committee received informational reports on 1) the AMBAG Line of Credit Renewal and Extension; 2) the Financial Update Report; and 3) the FY 2019-2020 AMBAG Staffing Assumptions. The consent calendar will be brought back to the March 2019 Executive/Finance Committee meeting for approval.

# B. Monterey Bay National Marine Sanctuary Advisory Council (SAC) Meeting

Maura Twomey, Executive Director reported that there were no action items at the December 2018 SAC meeting. Topics for the 2019 calendar year were discussed. Ms. Twomey stated that the SAC will be discussing the MBNMS Management Plan at the February 2019 meeting.

#### 11. EXECUTIVE DIRECTOR'S REPORT

Maura Twomey, Executive Director welcomed the new Board members. Ms. Twomey stated that she is scheduling one-on-one meetings with the new Board members to give them a brief history of the agency.

#### A. Minutes of the November 14, 2018 AMBAG Board of Directors Meeting

#### F. AMBAG Line of Credit Renewal and Extension

The request for renewal of \$100,000 line of credit and extension of the maturity date of the loan was approved.

# G. Draft Amendment No. 2 to the FY 2018-19 Overall Work Program (OWP) and Budget

The draft Amendment No. 2 to the FY 2018-19 OWP and Budget was approved.

# H. Financial Update Report

The financial update report was accepted.

Motion made by Director Phillips, seconded by Director Smith to approve the consent agenda. The motion passed unanimously.

# 14. ADMINISTRATION

# A. FY 2019-2020 AMBAG Staffing Assumptions

Maura Twomey, Executive Director, gave a report on the FY 2019-2020 AMBAG staffing assumptions. Ms. Twomey reported that AMBAG has not modified its classification salary ranges in over 10 years. Staff evaluated the various AMBAG classification against comparable local jurisdiction's and partner agencies' classification salary ranges. Staff also compared AMBAG's salary ranges with the Santa Cruz County Regional Transportation Commission's 2018 Classification and Compensation Study. The analysis showed that 1) some of AMBAG's classification salary ranges are up to 31 percent lower than our peer agencies' salary ranges; 2) most of the AMBAG classifications salary ranges are 8-12% lower

when compared to our local peers; and 3) AMBAG's salary schedule ranges would need to be adjusted by 3-11 steps to become on par with our local agencies. Ms. Twomey referred the Board to attachments 1 and 2. In the last several years, AMBAG has had difficulties in recruiting and retaining employees with positions vacant from six to nine months. The increase in salary ranges will enable AMBAG to better compete with local agencies and the Bay Area. Ms. Twomey recommends that AMBAG's classification salary ranges be modified and increased by three steps or 7.5% adjustment. The adjustment will not be an immediate raise to employees but would allow for additional merit increases. All salary compensation is fully reimbursable by state and federal funds. The Executive Director's salary will remain the same as it is set by contract by the AMBAG Board of Directors. Lengthy discussion followed.

By consensus, the Board directed staff to incorporate the 7.5% increase to the Overall Work Program (OWP) and budget for further discussion at the March 2019 AMBAG Board of Directors meeting. The Board also directed the Executive Director to reevaluate the salary compensation key positions such as the Director of Modeling and Director of Planning.
