6. PRESENTATIONS

A. Current CPUC Energy Efficiency Policy and Regional Energy Networks

Elisabeth Bertrand, Director of Special Projects gave a presentation on the current California Public Utilities Commission (CPUC) Energy Efficiency Policy and Regional Energy Networks (RENs). The CPUC and Regional Energy Networks 1) allowed only two RENs to begin operations; 2) they could only begin as pilot programs; 3) they were located in two large urban areas: Los Angeles and San Francisco; 4) the two programs were named SoCal REN and Bay REN; and 5) the two pilot RENS were set up to augment existing energy efficiency programs. The CPUC's goal of the pilot REN status is "to lead to a series of lessons learned". Mrs. Bertrand add that 1) AMBAG has been collaborating with partners working on energy efficiency in other rural regions; 2) the Rural and Hard to Reach Working Group has participated in the CPUC regulatory process to represent the rural regions of California; and 3) AMBAG has discussed the concept of serving rural customers with a REN. Brief discussion followed.

7. COMMITTEE REPORTS

A. Executive/Finance Committee

President McShane reported that the Executive/Finance Committee meeting did not meet due to lack of quorum.

B. Monterey Bay National Marine Sanctuary (MBNMS) Advisory Council (SAC) Meeting

President McShane gave a report on the February 21, 2020 SAC meeting. President McShane stated that the MBNMS Management Plan will be brought for approval at the April 2020 SAC meeting. President McShane stated that the SAC will be invited to a future AMBAG Board of Directors meeting to give a presentation on the Management Plan. The SAC received an update on marine debris. President McShane referred to a sample voluntary balloon ban letter provided by the MBNMS. Staff will forward a copy to the AMBAG Board of Directors for their jurisdictions consideration. The SAC was also received the MBNMS 2019 Accomplishments. Staff will forward this to the AMBAG Board of Directors.

8. EXECUTIVE DIRECTOR'S REPORT

Maura Twomey, Executive Director announced that Elisabeth Bertrand, Director of Special Projects would be retiring at the end of March 2020.

President McShane presented Mrs. Bertrand with a plaque and flowers for her dedication to AMBAG.

11. ADMINISTRATION

A. Draft FY 2020-21 Monterey Bay Region Overall Work Program (OWP) and Budget

Bhupendra Patel, Director of Modeling gave a presentation on the draft FY 2020-21 OWP and Budget. The FY 2020-2021 OWP is 1) a federally required document to receive federal funds; 2) covers all AMBAG work programs and activities; 3) used as a project management tool by staff; 4) implements 10 Federal Planning Factors; and 5) implements the AMBAG Board adopted priorities; a) Modeling and Research, b) Planning and Forecasts; c) Sustainable Development Strategies; and d) Collaborative Planning and Implementation. The FY 2020-2021 OWP highlights are 1) Development and management of current and future year OWP; 2) Regional coordination and FAST Act

implantation; 3) Development of the Public Participation Plan for the MTP/SCS and MTIP; 4) GIS data analysis, GIS Web portal and member services; 5) Maintain AMBAG Regional Travel Demand Model and development of the Activity Base Model for the 2045 MTP/SCS; 6) Local Government Planning support grant program for Housing; 7) monitoring and reporting Transportation Performance Management; 8) development and coordination of Regional Housing Need Assessment; 9) development and coordination of the 2045 MTP/SCS; 10) management of the FY 2018 MTIP and development of the draft FFY 2020 MTIP; 11) highway and transit corridor planning and management studies; 12) development of Greenhouse Gas Inventories; 13) Central Coast Highway 1 Climate Resiliency Study; and 14) provide technical assistance under RAPS, Inc. Dr. Patel reported that the draft FY 2020 – 2021 will be brought back to the May AMBAG Board of Directors for adoption. Dr. Patel gave an overview of the draft FY 2020-2021 Budget. The funding highlights are 1) it's a balanced budget pursuant to the AMBAG By-Laws; 2) there is no change to total member dues; and 3) revenue by source a) Federal - \$ 1,846,130; b) State - \$8,951,046; c) Local - \$423,950. The expenditure highlights are 1) staff level is maintained equivalent to FY 2019-2020; 2) there is a reduction in professional services due to project/grant closeout; 3) the General Fund expenditures include costs that are not eligible for Federal reimbursement, such as, interest, fees and cash match to meet federal/state grant requirements; and 4) continued use of toll credits preserves the General Funds. Brief discussion followed.

12. PLANNING

A. Draft 2022 Regional Growth Forecast

Heather Adamson, Director of Planning gave a presentation on the draft 2022 Regional Growth Forecast. Ms. Adamson reported that the 2022 Regional Growth Forecast (Forecast) for the AMBAG region shows slowing growth for employment and population. The Forecast is 1) updated every four years; 2) forecasts population, housing and employment for the tri-county region; 3) base year is 2015 and the horizon year is 2045; 4) it's the basis for planning for growth in the Metropolitan Transportation Plan/ Sustainable Communities Strategy (MTP/SCS), transportation project level analysis, corridor studies, and economic analysis; and 5) input for the Regional Travel Demand Model which forecasts travel patterns. The Forecast alone does not guide the Regional Housing Needs Allocation (RHNA). The RHNA methodology for disaggregation also considers 1) fair share (avoiding disproportionate income categories); 2) lack of serve capacity such as water (by statute); 3) market demands for housing; 4) needs of farm works; and 5) needs generated by a university or college. Ms. Adamson added RHNA discussion will begin in 2021 following the development of the Forecast. Ms. Adamson explained the difference between Regional Growth Forecasts and General Plans. 1) the purpose of the Forecast is to show what is likely to occur; 2) General Plans often look at full potential build out in order to address potential environmental impacts; 3) Regional forecast are being developed on a difference timeline than General Plans; and 4) due to different goals and different timelines the numbers will not match exactly with any given General Plan. The Forecast process is based on a methodology that predicts employment growth using a model based on local data as well as state and national trends. The AMBAG Industry Employment Forecast is driven by projected national and statewide trends for all industries in the region using a shift-share model. This is the same technique used in the last forecast. Ms. Adamson provided follow-up answers to employment questions from the February 2020 AMBAG Board of Directors meeting. The AMBAG Population Forecast is based historical trends in the ratio of population to employment in the AMBAG region. The draft Forecast projects that 1) region's population growth is slowing as reflected in lower 2020

Forecast update from the Department of Finance (DOF); 2) the AMBAG region is aging more rapidly than in prior forecasts; 3) there are smaller households that prior forecasts due to an aging population; and 4) there is a slightly lower household forecast. The AMBAG Housing Unit Forecast combines household forecast and the projected vacancy rate. The Housing Vacancy Rate forecast is higher than the 2018 Forecast. Ms. Adamson added that 1) employment data have been rebenchmarked to better reflect local industry; 2) population growth has slowed dramatically; 3) DOF forecast update is dramatically lower than prior projections; and 4) the housing growth may not slow as much as population growth with older population more likely to live alone. Brief discussion followed.

Motion made by Director Goetzelt, seconded by Director Freeman to accept the regional forecast numbers and direct staff to begin the disaggregation process to the county and city level. Motion passed unanimously.

BACKGROUND/DISCUSSION:

Since March 12, 1984, under adopted State Clearinghouse Procedures, the Association of Monterey Bay Area Governments (AMBAG) was designated the regional agency responsible for clearinghouse operations in Monterey, San Benito and Santa Cruz Counties. These procedures implement Presidential Executive Order 12372 as interpreted by the "State of California Procedures for Intergovernmental Review of Federal Financial Assistance and Direct Development Activities." They also implement the California Environmental Quality Act of 1970 as interpreted by CEQA Guidelines.

The purpose of the Clearinghouse is to provide all interested parties within the Counties of Monterey, San Benito and Santa Cruz notification of projects for federal financial assistance, direct federal development activities, local plans and development projects and state plans that are proposed within the region. These areawide procedures are intended to be coordinated with procedures adopted by the State of California.

FINANCIAL IMPACT:

There is no direct financial impact. Staff time for monitoring clearinghouse activities is incorporated into the current AMBAG Overall Work Program and budget.

Notices for the Clearinghouse are sent by lead agencies to AMBAG. Interested parties are sent email notifications twice a month with the newsletter attached.

The DRC Annex project would amend the Salinas Valley Memorial Healthcare System (SVMHS) Master Plan to relocate a planned parking structure along Los Palos Drive to the north east corner of San Jose Street and Wilgart Way. The new parking structure would serve as an extension, or annex, to the existing Downing Resource Center parking structure, and upon completion would provide a net increase of 166 parking spaces. The new structure has been designed to have a similar height and appearance to the existing structure. The basement level of the DRC Annex would include approximately 20,000 square feet of additional occupied hospital office and support space. Above the basement will be four levels of parking. The project includes ancillary improvements and relocation of certain hospital waste management functions (interim and permanent). These improvements include temporary relocation of general waste to 120 Wilgart Way, temporary on- site relocation hazardous and biohazardous waste yard, permanent relocation and consolidation of all waste streams, and pedestrian wayfinding/ ADA improvements near the hospital entrance.

Supplemental Environmental Impact Report

The Proposed Modifications to the approved Pure Water Monterey Groundwater Replenishment Project would increase the project yield so that the expanded project can serve as a back-up to the California American Water Company (CalAm) Monterey Peninsula Water Supply Project desalination project in the event that the desalination project is delayed beyond the Cease and Desist Order deadline of December 31, 2021. The Proposed Modifications would provide expanded quantities of purified recycled water for recharge of a groundwater basin that serves as drinking water supply. The Proposed Modifications would increase the amount of purified recycled water produced by the approved PWM/GWR Project by 2,250 AFY using the following new and modified facilities located within unincorporated Monterey County and City of Seaside: (1) improvements at the approved Advanced Water Purification Facility to increase peak capacity; (2) new product water conveyance facilities; (3) new and relocated injection well facilities, including monitoring wells; (4) new CalAm potable water facilities consisting of four new extraction wells, related pipelines and appurtenances, and treatment facilities; and (5) new CalAm potable water conveyance facilities. The Proposed Modifications are being proposed by M1W in partnership with the Monterey Peninsula Water Management District.

RECOMMENDATION:

The Association of Monterey Bay Area Governments, in conjunction with many partners, is developing a climate resiliency study for the Central Coast Highway 1 corridor from State Route 183 to Salinas Road including the rail line in this corridor. The Board is asked to accept an update an on the study.

BACKGROUND/DISCUSSION:

The Association of Monterey Bay Area Governments (AMBAG), in conjunction with The Nature Conservancy (TNC) and the Center for the Blue Economy of the Middlebury Institute of International Studies at Monterey (CBE), is developing a climate resiliency study for the Central Coast Highway 1 corridor from State Route 183 to Salinas Road including the rail line in this corridor. This effort will identify transportation improvements and sea level rise adaptation strategies that can improve transportation mobility, safety and efficiency, promote healthy habitats and provide economic security and benefits to the local community.

Similar to Highway 1, railways stretch along much of California's coast. This transportation infrastructure is critical to California's population and economy. There is also critical coastal habitat immediately adjacent to these highways and rails, which without concerted adaptation may be impacted or lost with sea level rise. Projects like this provide important insight into how to simultaneously enhance the resilience of transportation infrastructure and coastal habitats.

This study evaluated and identify the transportation needs, including the ultimate corridor concept in the Central Coast Highway 1 and rail corridor near the Elkhorn

Slough area while protecting and integrating the environmental needs of this unique corridor. There is a deficiency in this critical corridor where existing demand greatly exceeds the limited capacity, causing long delays. Highway and railroad infrastructure are prone to flooding and vulnerable to sea level rise, and are adjacent to valuable wetland habitats of an estuary of noted regional and national significance. Many of these valued habitats are also vulnerable to sea level rise. This study has an opportunity to increase the resilience of transportation infrastructure and habitat to sea level rise and climate change.

A Project Team and Steering Committee guide the development of the study. The Project Team and Steering Committee has held many meetings over the last few months to discuss various transportation and habitat adaptation strategies for both Highway 1 and the railway. A public workshop was held in February 2020 to receive input on the various adaptation strategies. The economic analysis of the various adaptation strategies is being finalized. A draft report is expected to be released in May 2020 for a 30-day public review period. A presentation on the draft report will be presented at the AMBAG Board meeting in June 2020. The Board of Directors will be asked to accept the final study report and direct staff to close out the grant at the August 2020 meeting.

Approve Formal Amendment No. 13 to the Monterey Bay Metropolitan Transportation Improvement Program (MTIP): FFY 2018-19 to FFY 2021-22.

BACKGROUND/ DISCUSSION:

The federally required Metropolitan Transportation Improvement Program (MTIP) is a comprehensive listing of surface transportation improvement projects for the tri-county Monterey Bay Region that receive federal funds or are subject to a federally required action, and/or are regionally significant.

AMBAG, as the federally designated Metropolitan Planning Organization (MPO) for the Monterey Bay Region, prepares and adopts the MTIP at least once every two years. The MTIP covers a four-year period and must be financially constrained by year, meaning that the amount of dollars committed to the projects (also referred to as "programmed") must not exceed the amount of dollars estimated to be available. The MTIP: FFY 2018-19 to FFY 2021-22 was adopted by the AMBAG Board at their September 26, 2018 meeting. It received state approval on November 2, 2018 and joint approval by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) on December 17, 2018. Upon the MTIP: FFY 2018-19 to FFY 2021-22 receiving federal approval, it was included in the 2019 Federal Statewide Transportation Improvement Program (FSTIP).

What constitutes Formal Amendment to the adopted MTIP?

- 1. Federal regulations require that any addition or deletion of a project within the first four years of the adopted MTIP require formal amendment.
- 2. A significant change in project scope of work and/or cost estimate over \$20 million or 50% of the total project cost as programmed within the first four years requires a formal amendment to the adopted MTIP. There is no limit on adding funds to a grouped project listing.

Who approves Formal Amendments to the MTIP?

- As per the federal requirements, each formal amendment to the MTIP is first circulated for public review and comments for a minimum of two weeks. Thereafter, the formal amendment is presented to the MPO Board for their approval.
- 2. After the MPO's approval, the formal amendment is submitted to the State Department of Transportation (Caltrans) for their approval.
- 3. After the State's approval, the formal amendment is forwarded to the FHWA and FTA for their joint approval.
- 4. Upon federal approval, the formal amendment by reference is included in the FSTIP.

Formal Amendment No. 13 to the MTIP: FFY 2018-19 to FFY 2021-22 updates four (4) projects, as listed in **Attachment 2**, Summary of Changes. The complete project listing included in Formal Amendment No. 13 is also enclosed with the agenda (**Attachment 3**) and can be viewed/downloaded using the AMBAG website link (www.ambag.org).

In accordance with the current federal regulations, the proposed Formal Amendment No. 13 is financially constrained to reasonably available resources. Projects included in Formal Amendment No. 13 have been developed in accordance with all applicable transportation planning requirements per 23 CFR Part 450 and are expected to support the establishment and achievement of performance management targets. The projects included in this formal amendment also meet the following general requirements for a project to be approved by the U.S. Department of Transportation as a part of the MTIP:

- 1) Projects must be consistent with AMBAG's adopted 2040 Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS);
- 2) Projects must be financially constrained; and
- 3) Projects must satisfy public review/comments requirements.

ALTERNATIVES:

The Board could take an action not to approve Formal Amendment No. 13 to the MTIP: FFY 2018-19 to FFY 2021-22. In this case, work on the projects included in this formal amendment could be put on hold.

FINANCIAL IMPACT:

This is a federally funded activity. Staff time to carry out the formal amendment process as well as cost for publication of the public notice in the local newspapers for public review and comment is programmed in the adopted FY 2019-20 Monterey Bay Region Overall Work Program (OWP) and Budget.

COORDINATION:

RECOMMENDATION:

Staff recommends that the Board of Directors accept the Financial Update Report.

BACKGROUND/DISCUSSION:

The enclosed financial reports are for the 2019-2020 Fiscal Year (FY) and are presented as a consent item. The attached reports contain the cumulative effect of operations through March 31, 2020 as well as a budget-to-actual comparison. Amounts in the Financial Update Report are unaudited.

FINANCIAL IMPACT:

The Balance Sheet for March 31, 2020 reflects a cash balance of \$739,544.26. The accounts and contractors receivable balance is \$572,500.64, while the current liabilities balance is \$226,529.13. AMBAG has sufficient current assets on hand to pay all known current obligations.

Due to the implementation of Governmental Accounting Standards Board (GASB) Statement No. 68 in FY 2014-2015 and a restatement to Net Position for GASB Statement No. 82, AMBAG has a deficit Net Position in the amount of \$157,321.63. Although AMBAG's Balance Sheet as of March 31, 2020 reflects a deficit Net Position, AMBAG's Profit and Loss Statement reflects an excess of revenue over expense of \$46,603.46. As we make efforts to pay the outstanding pension liability, AMBAG's Net Position will continue to improve.

Revenues/Expenses (Budget to Actual Comparison):

The budget reflects a linear programming of funds while actual work is contingent on various factors. Therefore, during the fiscal year there will be fluctuations from budget-to-actual.

Salaries and fringe benefits are under budget primarily due to positions that were vacant for portions of the fiscal year. In addition the Regional Early Action Planning Housing Program (REAP) providing \$7,931,311 in funding has been encumbered but has not been used.

Professional Services are under budget primarily due to the timing of work on projects performed by contractors. These projects include the Central Coast Highway 1 Climate Resiliency Study and the development of an Activity-Based Model (ABM) Framework for the Central Coast Supra-Region (AMBAG, SLOCOG and SBCAG). In addition, work has begun on the 2045 Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS). These projects are in various phases of completion. In addition the Regional Early Action Planning Housing Program (REAP) providing \$7,931,311 in funding of which a large portion will pass through to partner agencies, has not started this process.

Since AMBAG funding is primarily on a reimbursement basis, any deviation in expenditure also results in a corresponding deviation in revenue. Budget-to-actual revenue and expenditures are monitored regularly to analyze fiscal operations and propose amendments to the budget if needed.

(OWP) and Budget

MEETING DATE: May 13, 2020

RECOMMENDATION:

Staff recommends that the Board of Directors approve the following:

- 1) Adopt resolution 2020-4 (Attachment 1) approving Draft FY 2020-21 OWP and Budget and authorize staff to submit the Draft FY 2020-21 OWP to Caltrans and federal agencies for their approval;
- Certify AMBAG's adherence to the metropolitan transportation planning process within the region and authorize Executive Director to sign the certification (Attachment 2); and;
- 3) Authorize AMBAG staff to execute OWP Agreements to release funds for metropolitan transportation planning use.

BACKGROUND/ DISCUSSION:

The Fixing America's Surface Transportation Act (FAST Act) calls for the development of the Overall Work Program (OWP) and Budget by the federally designated Metropolitan Planning Organization (MPO). The Association of Monterey Bay Area Governments (AMBAG), as the federally designated MPO for the tri-county (Monterey, San Benito and Santa Cruz Counties) Monterey Bay Region, annually develops and maintains the OWP and Budget. Generally the Overall Work Program (OWP) and the AMBAG Budget are linked documents.

The Draft FY 2020-21 OWP is developed in consultation and coordination with the region's Regional Transportation Planning Agencies (RTPA), transit operators, Caltrans, Federal Highway Administration (FHWA) and Federal Transit Administration (FTA). The Draft FY 2020-21 Overall

Work Program (OWP) includes transportation and air quality related planning activities proposed for the Monterey Bay Region for the state fiscal year July 1, 2020 to June 30, 2021.

The Draft FY 2020-21 OWP incorporates the AMBAG Board adopted Overall Work Program priorities, as listed below.

- Modeling and Research,
- Planning and Forecasts,
- Sustainable Development Strategies, and;
- Collaborative Planning and Implementation.

At the March 11, 2020 meeting, staff presented the Draft FY 2020-21 OWP and Budget for AMBAG Board review and comments. Following the meeting, staff provided the same draft document to Caltrans, FHWA and FTA for their review and comments. AMBAG staff incorporated the comments received from the state and federal agencies in this final Draft FY 2020-21 OWP, as appropriate. A synopsis of the Draft FY 2020-21 Overall Work Program and Budget is provided in the Attachment 3. The Draft FY 2020-21 OWP and Budget is separately enclosed with the agenda packet and also available to view or download from the AMBAG website at www.ambag.org.

The Draft FY 2020-21 OWP and Budget presented at the March 11, 2020 AMBAG Board meeting included a 3.5% Cost of Living Adjustment (COLA) for AMBAG staff. Given the current economic uncertainty as a result of the COVID-19 pandemic, staff determined that it was fiscally prudent to eliminate the COLA from the final FY 2020-21 OWP and Budget. Although AMBAG does not anticipate any reductions in state or federal allocations at this time, this adjustment allows the agency to remain financially stable in the event of any significant program reductions.

Upon Board approval, the FY 2020-21 OWP will be forwarded to Caltrans, FHWA and FTA for their final approval.

Draft FY 2020-21 AMBAG Budget

Generally, the Overall Work Program (OWP) and the AMBAG Budget are linked documents. The AMBAG Draft FY 2020-21 Budget mirrors the activities and funding programmed in the Draft FY 2020-21 OWP. Staff provided the Draft FY 2020-21 AMBAG Budget at the March 11, 2020 Board of Directors meetings. The FY 2020-21 AMBAG draft Budget is balanced as required by the AMBAG bylaws.

The staff time to carryout draft OWP and Budget activities is funded through FHWA PL, FTA 5303 and other State and local funds as programmed in the approved FY 2020-21 OWP.

COORDINATION:

Preparation of the Draft FY 2020-21 OWP has been coordinated with Council of San Benito County Governments (SBtCOG), Monterey-Salinas Transit (MST), Santa Cruz County Regional Transportation Commission (SCCRTC), Santa Cruz Metropolitan Transit District (SCMTD), Transportation Agency for Monterey County (TAMC), California Department of Transportation (Caltrans), Federal Highway Administration (FHWA) and Federal Transit Administration (FTA).

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE ASSOCIATION OF MONTEREY BAY AREA GOVERNMENTS TO ADOPT THE AMBAG FY 2020-2021 OVERALL WORK PROGRAM AND BUDGET

WHEREAS, the Association of Monterey Bay Area Governments has been designated by the Governor of the State of California as the Metropolitan Planning Organization (MPO) for the Monterey Bay area; and

WHEREAS, the Fixing America's Surface Transportation Act (FAST Act) calls for the development of a Unified Planning Work Program (UPWP), or Overall, Work Program (OWP) and Budget under direction of the MPO in cooperation with the State and operators of publicly-owned transit; and

WHEREAS, in the Monterey Bay Region, the Comprehensive, Cooperative and Continuous transportation planning process also includes the regional transportation planning agencies, transit operators, Caltrans, the Federal Highway and Federal Transit Administrations; and

WHEREAS, the metropolitan planning regulations under Fixing America's Surface Transportation Act (FAST Act) require the MPO and Caltrans to annually certify that the metropolitan transportation planning process is being carried out in conformance with the following applicable laws and regulations:

- I. 23 U.S.C. 134, 49 U.S.C. 5303, and subpart C of 23 CFR part 450;
- II. In nonattainment and maintenance areas, sections 174 and 176(c) and (d) of the Clean Air Act, as amended (42 U.S.C. 7504, 7506(c) and (d)) and 40 CFR part 93;
- III. Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. 2000d–1) and 49 CFR part 21;
- IV. 49 U.S.C. 5332, prohibiting discrimination on the basis of race, color, creed, national origin, sex, or age in employment or business opportunity;
- V. Section 1101(b) of the FAST Act (Pub. L. 114-94) and 49 CFR part 26 regarding the involvement of disadvantaged business enterprises in USDOT funded projects;
- VI. 23 CFR part 230, regarding the implementation of an equal employment opportunity program on Federal and Federal-aid highway construction contracts;
- VII. The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) and 49 CFR parts 27, 37, and 38;
- VIII. The Older Americans Act, as amended (42 U.S.C. 6101), prohibiting discrimination on the basis of age in programs or activities receiving Federal financial assistance;

- IX. Section 324 of title 23 U.S.C. regarding the prohibition of discrimination based on gender; and
- X. Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and 49 CFR part 27 regarding discrimination against individuals with disabilities.

WHEREAS, the Association of Monterey Bay Area Governments is an eligible recipient of Federal, State, and local funding; and

WHEREAS, the Executive Director is authorized to enter into contracts for grants awarded for Federal, State, and local funding; and

WHEREAS, the Association of Monterey Bay Area Governments (AMBAG) wishes to delegate authorization to execute any agreements and any amendments thereto to the AMBAG Executive Director; and

WHEREAS, AMBAG's 2020-2021 fiscal year Overall Work Program and Budget describes the work and tasks to be completed; and

WHEREAS, the Overall Work Program and Budget provide for the funds necessary for AMBAG to accomplish its stated work and tasks in FY 2020-2021.

NOW, THEREFORE BE IT RESOLVED that the Board of Directors of the Association of Monterey Bay Area Governments:

- 1. Does hereby adopt the AMBAG FY 2020-2021 Overall Work Program and Budget including the list of AMBAG approved positions and salary ranges; and

Synopsis of the Draft FY 2020-21 Overall Work Program and Budget

The Draft FY 2020-21 Overall Work Program (OWP) and Budget includes transportation and air quality planning activities to be accomplished by AMBAG in consultation and collaboration with the region's Regional Transportation Planning Agencies (RTPAs), transit operators (Monterey Salinas Transit and Santa Cruz Metro Transit District), Federal Highway Administration (FHWA), Federal Transit Administration (FTA) and the California Department of Transportation (Caltrans). The OWP establishes transportation, air quality and other regional planning objectives, methods and timing for achieving those objectives, and identifies planning responsibilities and funding to complete the work. The OWP also serves as a management tool for AMBAG staff in that it identifies all projects and services to be provided during the year beyond those mandated by the metropolitan transportation planning process. The draft OWP and Budget, therefore, present an annual blueprint for the agency's use of resources for the state fiscal year 2020-21 (from July 1, 2020 to June 30, 2021).

The draft FY 2020-21 OWP programs various federal, state, regional and local funds to accomplish planning and project activities as included in the draft OWP. There are 25 work elements (WEs) included in the draft FY 2020-21 OWP, as follows:

- WE 101 Overall Work Program (OWP), Budget and Administration The OWP provides an overview of the region's Metropolitan Planning activities, with a focus on performance based transportation planning approach. The document is AMBAG's project management and monitoring tool for local, state, and federal funded transportation and air quality planning activities for the Monterey Bay Area.
- WE 112 Transportation Plans Coordination and Interagency Liaison The main objective of this work element is to facilitate coordination of metropolitan transportation planning and air quality planning activities within the tri-county (Monterey, San Benito and Santa Cruz) Metropolitan Transportation Planning Area.
- WE 113 Public Participation Plan This work element is to maintain the Public Participation Plan (PPP) and update the Title VI Plan. The PPP contains strategies and requirements for engaging the public on the various components of transportation planning activities/projects prepared by MPO (AMBAG).
- WE 122 Water-Related Plans Coordination and Interagency Liaison The purpose of this work element is to collect, process and transmit timely information and facilitate an interagency liaison role for regional water related issues.
- WE 231 GIS Analysis, Data Collection, Uniformity, Coordination and Access The purpose of this work element is to collect regional employment, transportation, economic, population, housing, water quality, land use, traffic/truck counts, goods movements and other data used for the development of the Regional Travel Demand Model, the Metropolitan Transportation Plan, the Metropolitan Transportation Improvement Program, and corridor/transit planning studies.

- WE 251 Regional Travel Demand Model (RTDM) The RTDM is used to support metropolitan transportation and air quality planning and programming activities within the tri-county Metropolitan Planning Area. AMBAG staff in consultation with Caltrans, local and regional agencies continuously collect, analyze and applies most recent population, employment and land use data to develop and enhance the RTDM as well as provides technical assistance/guidance to regional agencies, cities and counties including Caltrans for model use and its applications.
- WE 257 Central Coast Supra-Regional Activity-Based Model Framework Under this work element staff at AMBAG, SLOCOG, SBCAG, and Caltrans are partners in developing a cost-effective and advanced Activity-Based Model (ABM) framework for California's Central Coast region.
- WE 320 AMBAG PG&E Local Governments Partnership Program (Energy Watch) AMBAG Energy Watch is a program that provides energy efficiency and climate action planning to municipal governments and school districts.
- WE 331 AMBAG Community-wide Greenhouse Gas Inventory for Local Jurisdictions Program – Under this program AMBAG will complete annual Community-wide GHG Inventories for the jurisdictions in the Monterey Bay Community Power service territory.
- WE 343/344 Regional Early Action Planning In September 2019, the adopted FY 2019-20 California Budget (AB 74) and associated housing trailer bill (AB 101) established the Local Government Planning Support Grants Program, including the Regional Early Action Program (REAP) and directed the California Central Coast to create a multiagency working group to oversee implementation of this program. AMBAG was selected as the fiscal agent for the REAP funding in the Central Coast.
- WE 411 Clearinghouse This work element allows AMBAG to monitor regionally significant projects and their impact on the regional travel demand model and regional transportation performance targets.
- WE 502 Regional Analysis & Planning Services, Inc. Administration (RAPS) RAPS Administration oversees the operation of AMBAG's nonprofit arm, Regional Analysis and Planning Services (RAPS), Inc.
- WE 511 Regional Analysis & Planning Services, Inc. Technical Assistance Provides technical assistance to government agencies, non-profit organizations and private entities, as requested.
- WE 530 Pajaro River Watershed Flood Prevention Authority Administration Provides administrative services to the Pajaro River Watershed Flood Prevention Authority.
- WE 605/606 Sustainable Communities Planning These work elements will conduct local and regional multimodal transportation and land use planning that further the AMBAG's MTP/SCS, contribute to the State's GHG reduction goals, targets and other sustainability goals.

- WE 610 Transportation Performance Management (TPM) Under this Work Element staff will conduct research, identify, collect and develop a Transportation Performance Management (TPM) measure analysis framework for future use as established under MAP-21 and FAST Act.
- WE 621 Elderly & Disabled & Americans with Disabilities Act The purpose of this work element is to perform outreach, education, and coordination related to the Coordinated Public Transit-Human Services Transportation Plan (CPTP) and the Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS) as it relates to the CPTP.
- WE 622/624 Metropolitan Transportation Planning The purpose of these work elements is to develop/update and implement the Metropolitan Transportation Plan (MTP) for the Monterey Bay Metropolitan Planning Region, in accordance with MAP-21/FAST Act's regulations. AMBAG, SCCRTC, TAMC, SBtCOG, Caltrans, transit agencies (MST and SC METRO) coordinate and cooperatively develop the region's MTP (also see WE 624.) The MTP consists of a regional vision, policies and goals, transportation improvement projects and a financial forecast. The development and adoption of the MTP is a multi-year project with an expected adoption date of June 2022.
- WE 641/642 Metropolitan Transportation Improvement Program (MTIP) The MTIP implements the Monterey Bay Metropolitan Transportation Plan (MTP), as required by the Fixing America's Surface Transportation (FAST) Act, including projects that meet the region's performance measures and goals, as stated in the adopted 2040 MTP/SCS (access and mobility, economic vitality, environment, healthy communities, social equity, system preservation and safety). The main objective of these work elements is to maintain the federally mandated MTIP for FFY 2018-19 to FFY 2021-22 and to develop the MTIP for FFY 2020-21 to FFY 2023-24 for the AMBAG Region as a part of the metropolitan transportation planning requirements.
- WE 680 Rail Planning/Corridor Studies The purpose of this work element is to conduct and/or participate in feasibility studies, prepare plans for regionally significant major corridor studies including but not limited to rail, transit, highway corridors within the tri-county Monterey Bay Region.
- WE 684 Central Coast Highway 1 Climate Resiliency Study The eight-mile stretch of Highway 1 near Elkhorn Slough is already constrained and will be increasingly impacted by coastal storm flooding and sea level rise. Partners in the Monterey Bay area are joining together to find innovative ways to address this complex transportation adaptation problem by exploring creative transportation solutions and the use of natural infrastructure approaches to promote transportation, habitat and economic resilience for the region.

Draft FY 2020-21 AMBAG Budget Highlights:

The Draft FY 2020-2021 Budget is balanced as required by the AMBAG By-Laws. It reflects the continuation of steps taken by the Board of Directors and AMBAG staff to bring transparency, as well as improvement to the AMBAG budget and financial management. The details, projected outcomes, assumptions and potential risk factors affecting the FY 2020-2021 fiscal year budget are detailed below:

Revenue related summary

- Revenue of \$10,676,928 is anticipated for FY 2020-2021. The draft Budget assumes passage of the State budget in a timely fashion and assumes no delay in the receipt of revenues.
- Federal funding from the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) is programed in the draft OWP for AMBAG's transportation and air quality related planning activities and totals \$1,846,130 or 17.3% of total FY 2019-2020 funding.
- State funding provided by the California Public Utilities Commission (CPUC) for the Pacific Gas and Electric (PG&E) AMBAG Energy Watch Partnership program is \$40,000 which represents 0.4% of total FY 2020-2021 funding.
- Senate Bill 1 (SB1) funding will provide revenues of \$435,537 or 4.1% of total FY 2020-2021 funding.
- The Regional Early Action Planning Housing Program (REAP) is providing \$7,931,311 or 74.3% of total FY 2020-2021 funding.
- Local sources including RAPS, Monterey Harbormaster and the General Fund provide the remaining 3.9% or \$423,950 of total FY 2020-2021 funding.
- Toll credits of \$205,277 will be utilized in FY 2020-2021 to remain in compliance with federal and state matching requirements to receive transportation planning grant funding.

Expenditure related summary

- Salaries and Fringe Benefits of \$2,393,063 assume AMBAG will remain fully staffed for FY 2020-2021.
- Professional services are specialized services that are required for project implementation/completion. FY 2020-2021 projected costs are \$7,857,466. This includes the encumbrance of regional REAP funds for which AMBAG is the Fiscal Agent and will pass on to the member agencies.
- The ability to use toll credits for our non-federal local match will reduce the demand on our General Fund. This will allow those funds to be used for other

- purposes, including the ability to build a reserve which is reflected in the current budget.
- The General Fund Budget includes costs unallowable under any of AMBAG's grants or other fund sources, which include CALCOG related expenditures, fees and interest payments.

The FY 2020-2021 draft budget reflects staff's best projection of revenues and expenditures that AMBAG may encounter over the next fiscal year. Staff will continue to monitor and when necessary, bring to the Board of Directors amendments with more informed projections.

Planning Funding

MEETING DATE: May 13, 2020

RECOMMENDATION:

It is recommended that the Board of Directors discuss the draft approach for the allocation of the AMBAG Regional Housing Planning (REAP) Funding.

BACKGROUND

The adopted FY 2019-20 California Budget (AB 74) and associated housing trailer bill (AB 101) established the Local Government Planning Support Grants Program and made approximately \$8,000,000 available to the California Central Coast region to fund housing planning activities to enable jurisdictions to meet the 6th Cycle of the Regional Housing Needs Assessment (RHNA). The REAP program requires that funds be used for specific uses, including being suballocated directly and equitably to jurisdictions or other subregional entities for housing related planning, to improve the methodology used by Councils of Governments (COGs) for the distribution of the Sixth Cycle of the Regional Housing Needs Allocation (RHNA) and for administering the grant program.

In conformance with grant program requirements, the Association of Monterey Bay Area Governments has prepared a draft approach for allocating this regional housing planning funding to the Central Coast region. This approach was prepared with feedback from the Council of San Benito County Governments (SBCOG), San Luis Obispo Council of Governments (SLOCOG) and the Santa Barbara County Association of Governments (SBCAG) and reflects the individual needs and challenges of each council of governments. This approach was also discussed and approved by the Central Coast Housing Working Group (CCHWG) at its April 24, 2020 meeting.

DISCUSSION:

The CCHWG approved approach allocates the REAP funding to each of the four COGs by population to ensure geographic equity. Each COG must then approve its own suballocation approach within their subregion. COGs may use a portion of the funds to develop an improved methodology for the distribution of the 6th Cycle of RHNA. COGs shall determine how to best allocate the remaining funding to jurisdictions or other subregional entities within their jurisdiction for planning that will accommodate the development of housing and infrastructure to accelerate housing production in a way that aligns with state planning priorities, housing, transportation, equity, and climate goals. COGs may choose to disburse funds through a process that focuses on geographic equity or other discretionary processes to meet program goals. Funds shall only be used for housing-related planning activities and grant administration, including, but not limited to, the following:

- Performing infrastructure planning, including for sewers, water systems, transit, roads, or other public facilities necessary to support new housing and new residents.
- Technical assistance in improving housing permitting processes, tracking systems, and planning tools.
- Performing feasibility studies to determine the most efficient locations to site housing.
- Establishing regional or countywide housing trust funds for affordable housing.
- Covering the costs of temporary staffing or consultant needs associated with the activities described above.
- Providing jurisdictions and other local agencies with technical assistance, planning, temporary staffing or consultant needs associated with updating local planning and zoning documents, expediting application processing, and other actions to accelerate additional housing production

All fund recipients shall completely expend all funds towards approved purposes no later than December 31, 2023 per program requirements.

Draft Approach for the Allocation of Regional Early Action Planning Funding

AMBAG's total REAP allocation is \$3,651,516. AMBAG proposes to allocate \$3,300,000 million of its total \$3,651,516 to the local jurisdictions within Monterey and Santa Cruz

Counties. Each jurisdiction would be eligible to receive REAP funding according to population thresholds used in the statewide Local Early Action Planning (LEAP) grant program.

Local jurisdictions are encouraged to align REAP funding with previous SB 2 planning and LEAP planning efforts. AMBAG staff proposes that maximum grant amounts shall be set as follows, according to 2019 population estimates:

	Max Award
Jurisdiction Size*	Amount
Less than 20,000 =	\$65,000
20,000 - 59,999 =	\$165,000
60,000 - 99,999 =	\$300,000
100,000 - 199,999 =	\$530,000

^{*}Same population thresholds as the HCD LEAP program.

The remaining funds (\$351,516) will be used by AMBAG to prepare the 6th Cycle RHNA Methodology and Allocation and other regional housing planning activities.

AMBAG staff reached out to the Planning Directors from the local jurisdictions within Monterey and Santa Cruz Counties and there is support for this allocation approach. The AMBAG Board of Directors is asked to discuss this proposed approach and will be asked to approve a suballocation approach later this spring. AMBAG expects to suballocate the REAP funding to local jurisdictions later this summer. Local jurisdictions in Santa Cruz and Monterey Counties will be asked to submit an application to AMBAG outlining proposed scope, schedule, budget and deliverables for the REAP funding.

Due to the legislation which established the REAP program, the approach for REAP funding distribution in the San Benito County area will be implemented by the Council of San Benito County Governments (SBtCOG).

FINANCIAL IMPACT:

This is a discussion item and has no fiscal impact. Once the Board approves an approach for allocating Regional Early Action Planning funding for the AMBAG region at a later meeting, AMBAG will begin the process of implementing the application, contract, and financial framework for disbursing \$3,651,516 in housing planning funding to jurisdictions in the Santa Cruz County and Monterey County area.

COORDINATION:

AMBAG coordinated with the planning directors from cities and counties in the Santa Cruz County and Monterey County area to identify a feasible approach for the allocation of regional housing funds.
