AMBAG staff provided input on issues of regional significance and worked collaboratively to meet interagency coordination needs. Staff participated in multiple workshops, webinars as well as conference call meetings pertaining to performance measure discussions.

Draft FY 2022-23 Expenditure Highlights

- Maintaining staff level equivalent to current year
- Includes 4% COLA
- Increase in professional services due to REAP and new grant projects
- General Fund expenditures includes costs that are not eligible for federal reimbursement:
 - Interest and fees
 - Cash match to meet federal/state grant requirements
- Use of toll credits to match federal funds, preserves
 General Fund

MTP/SCS Background

- Long range plan for transportation investments
- Federal and state law requires that a MTP/SCS be prepared every four years
- Must provide a 20+ year horizon planning period
- 2045 MTP/SCS scheduled for adoption in 2022

Public Comment Period

- AMBAG released the Draft 2045 MTP/SCS on November 22, 2021
- Comments were due on January 31, 2022
- Held four public workshops/public hearings
- Received more than 50 comments from more than eight individuals and/or organizations

Summary of Public Comment

- Support for/opposition to transportation modes and specific projects
- Comments on the MTP/SCS document and figures
- Comments on the Project List
- Comments on sustainability and climate change issues
- Draft EIR is scheduled to be released for public comment in November 2021

Comments Received on the DEIR

- Nine individuals/organizations submitted comments on the Draft Environmental Impact Report
- Environmental project team is preparing responses to the comments received
- Provided in the Final EIR

Proposed Changes for the Final 2045 MTP/SCS

- Refinements to project costs, project descriptions and revenues
 - Consistent with requests from the RTPAs
- Additions/modifications to document text to provide greater clarification and additional discussion
- Revised figures/maps
- None of the proposed changes would trigger recirculation of the MTP/SCS or EIR

Next Steps

- April 13, 2022 Approve proposed changes to the 2045 MTP/SCS and direct staff to prepare the Final 2045 MTP/SCS and Final EIR
- June 8, 2022 AMBAG Board certifies Final EIR and adopts Final 2045 MTP/SCS
- Submit adopted 2045 MTP/SCS to CARB for **SCS** review
