RHNA Methodology Overview

- ▶ COG responsible for developing a methodology appropriate for each region
- Must further and support 5 RHNA objectives
 - Increases housing supply & mix
 - Promotes infill, equity, and environment
 - Ensure jobs-housing balance/fit
 - Promote regional income parity
 - Affirmatively furthers fair housing
- Statute allows for flexibility but specifies what can and cannot be used as allocation factors



Draft RHNA Methodology Process

- Developed & evaluated various RHNA methodology options with extensive public input over a 9-month period
- Board approved draft RHNA methodology at its January 12, 2022 meeting and directed staff to submit draft methodology to HCD
- HCD completed its review of the methodology and found that the draft RHNA methodology furthers the statutory objectives described in Government Code 65584(d)

Final RHNA Methodology Steps

- ▶ 1st Step 2022 RGF (Base Unit Allocation)
 - Distributes portion of RHNA based on four-year housing growth from the 2022 RGF
- ▶ 2nd Step Jobs, Transit, Resiliency, and AFFH (Unit Allocation)
 - Jurisdiction's share of 2020 jobs (15%)
 - Jobs/housing ratio (31%)
 - Jurisdictions with existing (2020) transit routes with 15- and 30minute headways (4%)
 - Jurisdictions who have the smallest percentages of high fire or high sea level risk (8%)
 - Jurisdictions full or partial RCAAs and TCAC based on households (42%)
- ▶ 3rd Step Income Allocation
 - Redistributes a portion of V.L and L income units to RCAA jurisdictions


Next Steps

- Upon approval and direction from the Board of Directors...
 - AMBAG staff will release the Draft RHNA Plan allocating shares of the regional housing need to AMBAG's member jurisdictions
 - The release of the Draft RHNA Plan initiates a 45-day appeal period allowing a member jurisdiction or HCD to appeal for a revision of the share of the regional housing need proposed to be allocated (Gov. Code, § 65584.05(b).)
 - Draft RHNA Plan scheduled for release on April 22, 2022

Recommendation

- A. Hold public hearing to receive public comment on the final 6th Cycle Regional Housing Needs Allocation (RHNA) methodology for allocation of housing need to the region's jurisdictions consistent with the objectives of Government Code § 65584(d) and factors of Government Code § 65584.04(e)
- B. Approve the final RHNA methodology and authorize AMBAG staff to release the Draft RHNA Plan for a 45-day public review period

Regional Early Action Planning Grants (REAP 2.0) Program

Background

- Builds on the success of 2019's REAP program but expands the focus by integrating housing and climate goals
 - Allowing for broader planning and implementation investments, including infrastructure investments that support future housing development
- REAP 2.0 is intended to meet multiple objectives
 - Infill development
 - Housing for all incomes
 - Vehicle miles traveled (VMT) reduction
 - Affirmatively furthering fair housing (AFFH) goals

REAP 2.0 Program Objectives

- REAP 2.0 provides funds to accelerate housing production and facilitate compliance with the 6th Cycle of the housing element, including RHNA allocations
- In addition, REAP 2.0 provides MPOs with tools and resources to help implement and advance the SCS
- The REAP 2.0 objectives are:
 - Accelerate infill development that facilitates housing supply, choice and affordability
 - Affirmatively furthering fair housing
 - Coronavirus Economic Recovery
 - VMT reduction

REAP 2.0 Funding

- Funded with \$500 million from the Coronavirus State and Local Fiscal Recovery Funds of 2021 and \$100 million from the State General Fund
- The REAP 2.0 Program will be administered by HCD in collaboration with OPR, SGC and CARB
- Most of the funds (85%) will be allocated directly to the MPOs; remaining funds to be split between non-MPO, regions, Tribal entities, as well as statewide competitive pot for Higher Impact Transformative Projects
- AMBAG's formula share of the MPO funding is \$10,133,742



REAP 2.0 Draft Guidelines

- HCD released the REAP 2.0 draft guidelines for public review & comment on March 24, 2022
- Public comments are due on April 15, 2022
- AMBAG staff is reviewing the guidelines and will submit comments to HCD
- The final guidelines and the notice of funding availability (NOFA) is expected to be released in late April/early May 2022



Initial Thoughts on the REAP 2.0 Draft Guidelines

- AMBAG staff is concerned that most of the funding is federal funding and eligible uses are extremely restricted
- In addition, the REAP 2.0 draft guidelines require that the funding be spent on communities negatively impacted by COVID-19 which also limits how AMBAG can spend the funding



AMBAG's REAP 2.0 Program Development

- The REAP 2.0 Program can be used for transformative and implementation activities
- After the final guidelines and NOFA are released, AMBAG will work with the Board, partners, stakeholders and the public to develop:
 - Priorities and proposed uses
 - Funding amounts and the appropriate blend of planning and implementation
 - Various other program components



REAP 2.0 Program Timeline

- March 24, 2022 HCD releases draft guidelines
- April 15, 2022 Comments due on the draft REAP 2.0 Program Guidelines
- Late April/early May 2022 HCD releases final guidelines and NOFA
- Summer 2022 December 2022 AMBAG develops regional approach and submits REAP 2.0 application to HCD
- December 31, 2022 Deadline to submit application for REAP 2.0
 Program funds and include a budget, amounts retained by the regional agency and any sub-allocations, and an education and outreach strategy
- June 30, 2024 Deadline for REAP 2.0 recipient to encumber funds
- June 30, 2026 Deadline for REAP 2.0 funds to be expended

- AMBAG will submit comments on the draft guidelines for the REAP 2.0 Program
- Staff will begin work on developing the AMBAG regional REAP 2.0 Program
