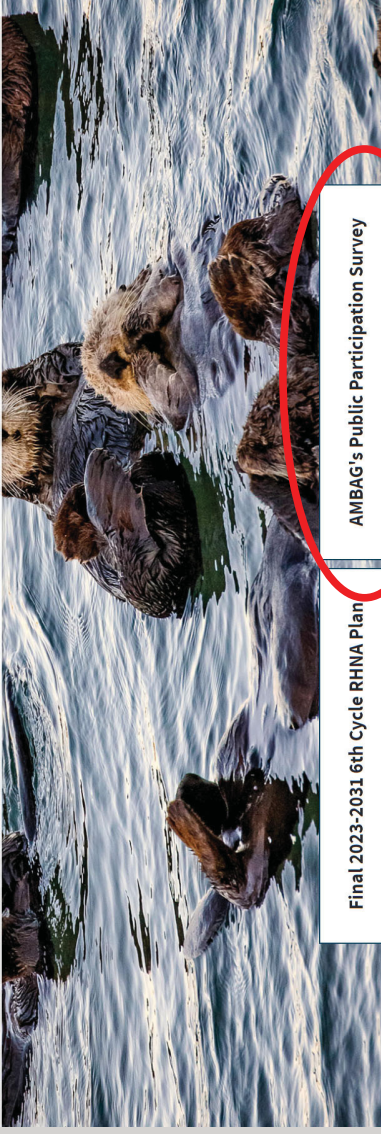

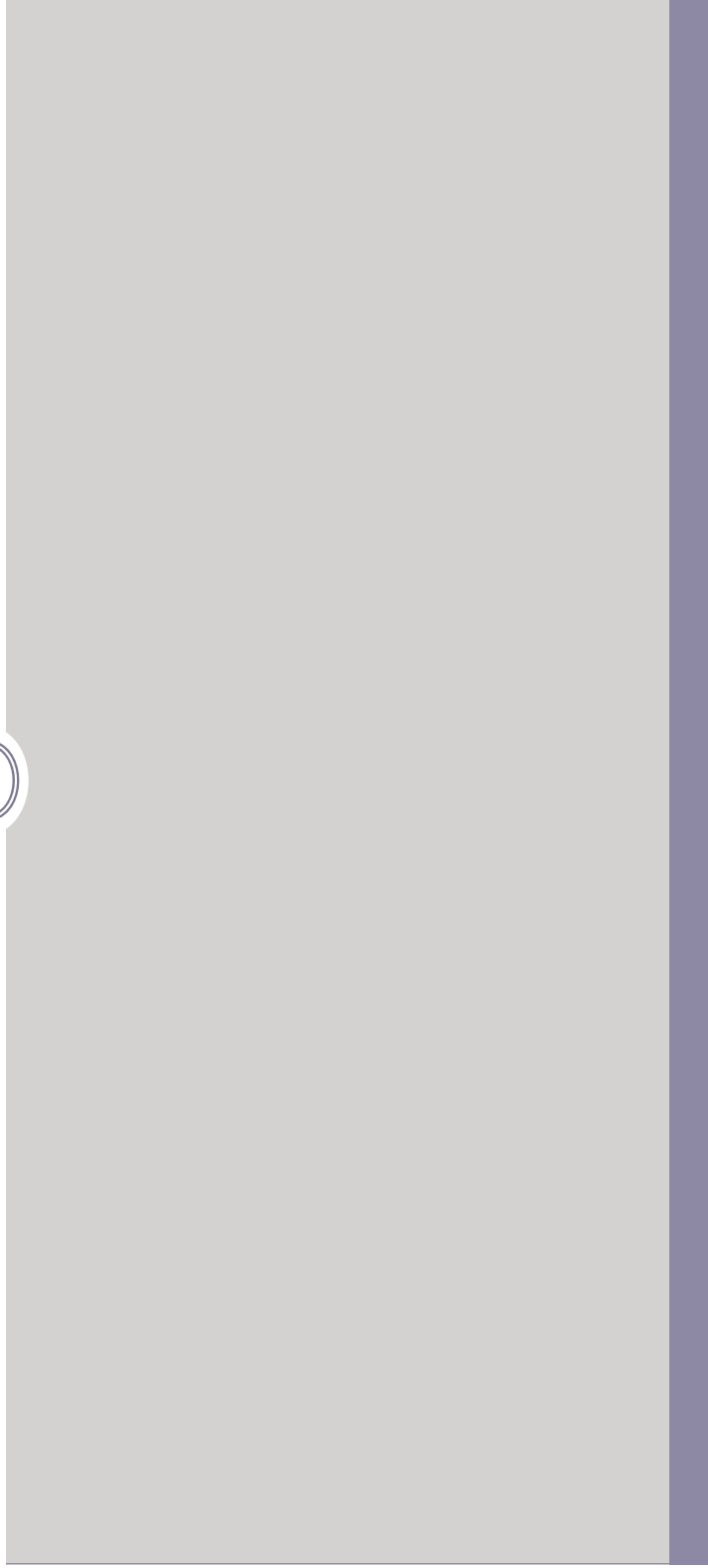
Key Dates
